SECTION VIII: ELECTRICAL INSPECTIONS:

- A. A permit (with corresponding inspection) shall only be required under the following three circumstances:
 - Construction of a new building or structure (no prior electrical service, either temporary or permanent);
 - 2. For buildings or structures that have been without electric service for a period of 90 days;
 - 3. If the electrical meter was disconnected and either moved from its original location on the building or structure or was replaced and/or repaired.
 - 4. For an existing service where service was disconnected by the electric utility for electrical repairs to the customer's side of the electrical meter.
- B. The following circumstances shall specifically be EXEMPT FROM ELECTRICAL INSPECTIONS (thus, a permit is NOT required prior to electrical service being made available to the building or structure):
 - Trimming of trees.
 - 2. Where a change of occupancy of a building or structure has occurred or where a new tenant has moved into a building or structure.
 - 3. Reconnection of electrical service within 90 days from the date electrical service was discontinued from a building or structure, whether the discontinuance of service was due to non-payment of electrical service Acts of God, animals or any other reason not specified in Section VIII.A.

All ordinances or parts of ordinances which pertain to electrical inspections and permits and/or which are in conflict with this amendment are, to the extent of such conflict, hereby repealed. It is the intent of the City Council to make this Amended Ordinance the final word on the subject matter contained herein.
