ORDINANCE 2006-1 ORDINANCE TO ANNEX CONTIGUOUS PROPERTY

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HAMILTON AS FOLLOWS:

WHEREAS, The City Hamilton is the owner of property located and contained within an area contiguous to the corporate limits of the City of Hamilton, the City has filed a written petition with the City Clerk of the City of Hamilton, requesting that such property be annexed to the City of Hamilton, and,

WHEREAS, such property does not lie within the corporate limits or police jurisdiction of any other municipality and the governing body of the City of Hamilton desires to adopt an ordinance pursuant to the provisions of 11-42-20, et seq., Code of Alabama, 1975, indicating its assent to the annexation of such property, thereby extending the corporate limits of the City of Hamilton so as to embrace and include such property,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Hamilton, Alabama, that the governing body of said City does hereby assent to the annexation of the following described property to the City of Hamilton, Alabama:

A tract of land containing 69.857 acres, being situated in the South ½ of the Southeast 1/4 of Section 21, Township 11 South, Range 14 West, Marion County, Alabama and being more particularly described as follows to-wit: "Beginning at the Southeast corner of said Section 21; thence run N.89 degrees 49' W. Along the South boundary of said Section 21, a distance of 1882.99 feet to its intersection with the Easterly right-of-way of Marion County Highway Number 55; thence run in a Northwesterly direction (chord bearing = N. 42 degrees 59' 31" W.) Along the Easterly right-of-way of said highway and along the arc of a curve to the right (central angle = 02 degrees 59' 02", radius = 1110.92 feet), an arc distance of 57.86 feet to the P.T. of said curve; thence run N. 41 degrees 40'W. And continue along the Easterly right-of-way of said highway, a distance of 210.00 feet to the P.C. of a curve to the right; thence continue in a Northwesterly direction (chord bearing = N. 34 degrees 42' 57" W.) Along the Easterly right-ofway of said highway and along said curve to the right (central angle = 13 degrees 34' 05", radius = 1397.40 feet), an arc distance of 330.91 feet to the P.T. of said curve; thence run N. 27 degrees 56' W and continue along the Easterly right-of-way of said highway a distance of 814.99 feet to the P.C. of a curve to the right; thence continue in a Northwesterly direction (chord bearing = N. 21 degrees 22' 14" W.) Along the Easterly right-of-way of said highway and along the arc of said curve to the right (central angle = 13 degrees 08' 50", radius = 601.61 feet), an arc distance of 138.05 feet to its intersection with the North boundary of the above said South ½ of SE 1/4; thence run N. 89 degrees 57' E. Along the North boundary of said South 1/2 of SE 1/4, a distance of 2610.91 feet to the Northeast corner of said South 1/2 of SE 1/4; thence run S. 03 degrees 04' E. Along the East boundary of the above said Section 21, a distance of 1330.31 feet to the point of beginning." (Charles Herman Gann)

A tract of land containing 17.245 acres, being situated in the Northeast 1/4 of the Northwest 1/4 Section 27, Township 11 South, Range 14 West, Marion County, Alabama and being more

of 350.29 feet to its intersection with the Westerly right-of-way of Corridor "X"; thence run S 63 degrees 21' E along the Westerly right-of-way of said Corridor "X", a distance of 252.04 feet to a concrete right-of-way monument; thence run S 50 degrees 02' E and continue along the Westerly right-of-way of said Corridor "X", a distance of 80.95 feet to a concrete right-of-way (chord bearing = S 46 degrees 14' E) along the Westerly right-of-way of said highway and along the arc of said curve to the right (central angle = 03 degrees 54' 36", radius = 11309.16 feet), an arc distance of 771.76 feet to a point; thence run s 03 degrees 04' E, parallel with the West boundary of the above said NW 1/4 of SW 1/4, a distance of 622.97 feet to an old concrete monument situated on the South boundary of said NW 1/4 of SW 1/4, a distance of 662.40 feet to the point of beginning."

A tract of land containing 10.489 acres, being situated in the North ½ of the SE 1/4 and in the South ½ of the NE 1/4, all in Section 21, Township 11 South, Range 14 West, Marion County, Alabama and being more particularly described as follows: Commence at the NE corner of the NE 1/4 of SE 1/4 of said Section 21; thence run N. 89 degrees 18' W along the North boundary of said NE 1/4 of SE 1/4, a distance of 495.09 feet to the point of beginning of the tract of land herein described to wit; thence run S 03 degrees 01' E, a distance of 389.41 feet to the head of a ditch and an old fence corner; thence run the following consecutive bearings and distances down said ditch and old fence (s 86 degrees 06' W, 319.40 feet; N 87 degrees 01' W, 156.47 feet; N 85 degrees 04' W, 232.24 feet; N 71 degrees 26' W, 161.71 feet; S 83 degrees 48' W, 62.84 feet; S 89 degrees 03' W, 75.32 feet; N. 76 degrees 58' W, 47.36 feet) to a ½ inch capped rebar; thence run N 30 degrees 37' W a distance of 401.11 feet to a 2 inch capped iron pipe situated on the Easterly right-of-way of Marion County Highway Number 55; thence run in a Northeasterly direction (chord bearing = N 45 degrees 36' 21" E) along the Easterly right-of-way of said highway and along the arc of a curve to the left (central angle -07 degrees 24' 13", radius = 1437.73 feet), an arc distance of 185.65 feet to the P.T. of said curve; thence run N 41 degrees 54' E and continue along the Easterly right-of-way of said highway, a distance of 42.52 feet to a 2 inch capped iron pipe; thence run S 42 degrees 55' E, a distance pf 298.46 feet to a 2 inch capped iron pipe; thence run N 65 degrees 48' E, a distance of 120.60 feet to a 2 inch capped iron pipe situated at an old fence corner and on the North boundary of the above said NE 1/4 of SE 1/4; thence run S 89 degrees 18' E along the North boundary of said NE 1/4 of SE 1/4, a distance of 753.11 feet to the point of beginning.

A tract of land containing 2.292 acres, being situated in the South ½ of the NE 1/4 and in the North ½ of the SE 1/4, all in Section 21, Township 11 South, Range 14 West, Marion County, Alabama and being more particularly described as follows: Commence at the NE corner of the NE 1/4 of SE 1/4 of said Section 21; thence run N 89 degrees 18' W along the North boundary of said NE 1/4 of SE 1/4, a distance of 1248.20 feet to a 2 inch capped iron pipe, said pipe being the point of beginning of the tract of land herein described to-wit; thence run S. 65 degrees 48' W, a distance of 120.60 feet to a 2 inch capped iron pipe; thence run N 42 degrees 55' W, a distance of 298.46 feet to a 2 inch capped iron pipe situated on the Easterly right-of-way of Marion County Highway Number 55; thence run N. 41 degrees 54' E along the Easterly right-of-way of said highway, a distance of 85.38 feet to a concrete right-of-way monument marking the P.C. of a curve to the left; thence continue in a Northeasterly direction (chord bearing = N. 31 degrees 26'

54" E) along the Easterly right-of-way of said highway and along the arc of said curve to the left (central angle = 20 degrees 54' 43", radius = 751.20 feet), an arc distance of 274.17 feet to a ½ inch capped rebar marking the beginning of a right-of-way flare; thence run N. 39 degrees 40' 34" E along the said right-of-way flare, a distance of 124.56 feet to its intersection with an old fence; thence run S 03 degrees 31' E along the said old fence, a distance of 562.18 feet to the point of beginning. (James & Mary White)

Along the Westerly right-of-way of said Corridor X and along the arc of a curve to the right (central angle = 10 degrees 05' 39", radius = 11309.16 feet), an arc distance of 1992.41 feet to a concrete right-of-way monument marking the P.T. of said curve; thence run S 34 degrees 19' E and continue along the Westerly right-of-way of said Corridor X, a distance of 498.86 feet to its intersection with the South boundary of the above said South 1/2 of Southwest 1/4; thence run N 89 degrees 53' W along the South boundary of said South ½ of SW 1/4, a distance of 1096.58 feet to the point of beginning. SUBJECT TO, however, a 200 foot wide right-of-way in favor of Tennessee Valley Authority for a High Voltage Transmission line, which runs a Northeast-Southwest direction through the South-Central portion of the herein above described tract of land.

A tract of land containing 30.406 acres, being situated in the SW 1/4 of Section 21, Township 11 South, Range 14 West, Marion County, Alabama and being more particularly described as follows to-wit: "beginning at the Southwest corner of said Section 21; thence run N. 03 degrees 04' W along the West boundary of said SW 1/4 of SW 1/4 a distance of 1330.31 feet to the Northwest corner of said SW 1/4 of SW 1/4; thence run S. 89 degrees 53' E along the North boundary of said SW 1/4 of SW 1/4, a distance of 993.19 feet to an old barbed wire fence; thence run S. 03 degrees 24' E along said old barbed wire fence, a distance of 1330.83 feet to a point on the South boundary of said SW 1/4 of SW 1/4; thence run N. 89 degrees 53' W along the South boundary of said SW 1/4 of SW 1/4, a distance of 1001.12 feet to the point of beginning: SUBJECT TO, however, a 200.0 foot wide right-of-way in favor of Tennessee valley Authority for a High Voltage Transmission line, which runs a Northeast-Southwest direction through the Southeast corner of the herein above described tract of land." BE IT FURTHER ORDAINED that the corporate limits to the City of Hamilton are hereby extended and rearranged so as to embrace and include the foregoing and such property shall hereby become a part of the corporate area of the City of Hamilton upon the date of publication of this Ordinance.

IT IS FURTHER ORDAINED that a certified copy of this Ordinance together with a map of said property showing its relationship to the corporate limits of the City of Hamilton and the Petition for Annexation be delivered by Honorable Ray Harper, Mayor, to Honorable Annette Bozeman Haney, Judge of Probate of Marion County, Alabama, for recording upon the public records of Marion County, Alabama.

Shane Stidham made a motion that this Ordinance be approved with a second by Scotty Sanderson. After discussion and upon a vote being taken, those voting in favor of the Ordinance

were as follows: Mayor Ray Harper, Councilwoman Annette Sherrill, Councilman McDavid Franks, Councilman Richard Gann, Councilman Shane Stidham and Councilman Scotty Sanderson. Those voting "Nay" were none.

The Mayor then announced that said Ordinance had been in all things duly and legally adopted.
