TO THAT CERTAIN PETITION FOR ANNEXATION FILED BY

TRACT A:

A 1.43 acre tract of land situated in the East $\frac{1}{2}$ of the Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 33, Township 10 South, Range 13 West and being more particularly described as follows: Commence at the Southwest corner of the East $\frac{1}{2}$ of the Southeast $\frac{1}{4}$ of Southwest $\frac{1}{4}$ of Section 33, Township 10 South, Range 13 West and run East, along the Southerly boundary of said Section 33, a distance of 234.15 feet to a point; thence run N. 00 degrees 25' E. a distance of 152.50 feet to an iron spike situated on the Easterly right-of-way of Marion County Highway No. 49, said iron spike being the point of beginning of the tract herein described to-wit; thence continue N. 00 degrees 25' E, along the Easterly right-of-way of said Highway No. 49, a distance of 120.00 feet to an iron pin set; thence run S. 48 degrees 14' E. a distance of 273.18 feet to an iron pin set; thence run S. 06 degrees 13' W. a distance of 60.00 feet to an iron pin set on the Northerly right-of-way of U. S. Highway No. 278; thence run N. 58 degrees 27' W., along the northerly right-of-way of U. S. Highway No. 278 and along the Easterly right-of-way of the above said Highway No. 49, a distance of 232.47 feet to the point of beginning.

TRACT B:

A 0.11 acre tract of land situated in the East $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 33, Township 10 South, Range 13 West and being more particularly described as follows: Commence at the Southwest corner of the East $\frac{1}{2}$ of Southeast $\frac{1}{4}$ of Southwest $\frac{1}{4}$ of Section 33; thence East, along the Southerly boundary of said Section 33, a distance of 234.15 feet; thence N. 00 degrees 25' E. a distance of 152.50 feet to an iron spike situated on the Easterly right-of-way of Marion County Highway No. 49. Said iron spike being the poing of beginning of the tract herein described to-wit; thence S. 41 degrees 42' E., along the revised easterly right-of-way of said Highway No. 49, a distance of 148.39 feet to its intersection with the Northerly right-of-way of U. S. Highway No. 278; thence S. 83 degrees 47' E., along the Northerly right-of-way of said Highway No. 278, a distance of 100.00 feet the point of intersection of the former right-of-way of the above said County Highway No. 49 with the northerly right-of-way of U. S. Highway No. 278; thence N. 58 degrees 27' W., along the former easterly right-of-way of County Highway No. 49, a distance of 232.47 feet to the point of beginning.
