ORDINANCE NO. 397A

BE IT ORDAINED by the City Council of the City of Hamilton, Alabama, being the governing body of said City does hereby assent to the annexation of the following described property to the City of Hamilton, Alabama for the improvement of public health and or public good, to-wit:

The North $\frac{1}{2}$ of North $\frac{1}{2}$ of Section 5, The North $\frac{1}{2}$ of North $\frac{1}{2}$ of Section 6, The Northwest $\frac{1}{4}$ of Northwest $\frac{1}{4}$ of Section 4, The West $\frac{1}{2}$ of Northeast $\frac{1}{4}$ of Northwest $\frac{1}{4}$ of Section 4, all in Township 11 South, Range 13 West; ALSO all the East $\frac{1}{2}$ of the Southwest $\frac{1}{4}$ of Southwest $\frac{1}{4}$ and all the West $\frac{1}{2}$ of the Southeast $\frac{1}{4}$ of Southwest $\frac{1}{4}$ of Section 33, Township 10 South, Range 13 West lying South of U.S. Highway No.278.

A motion was made by (Councilman) Tommy Fikes to accept a petition dated the 30th day of January, 1978 and signed by the property owners of the above described lands; and moved for the immediate enactment of this ordinance; this motion was seconded by (councilman) Larry Davis

MINUTES OF A REGULAR MEETING OF THE MAYOR
AND CITY COUNCIL OF THE CITY OF HAMILTON, ALABAMA

March 13, 1978

A regular meeting of the Mayor and City Council of the City of Hamilton was held in the Council room at 6:30 p.m. with the following members present:

Absent: Councilmen Lowell Cantrell and Bobby Loden


Mayor Sims called the meeting to order. A motion was made by Larry Davis to pay all bills for March. This motion was seconded by John Tuck and passed.

A motion was made by John Tuck to authorize the Fire department to equip a 1973 Ford (formerly used as a Police car) to be used by the Assistant Fire Chief in going to and from work in connection with Fire department work only. This motion was seconded by Larry Davis and passed unanimously.


A motion was made by Tommy Fikes to accept a petition dated January 30, 1978, from residents on East 278 Highway (south side) to be accepted into the Hamilton City limits. Legal description as follows:

Begin at the southwest corner of Section 31, Township 10 South, Range 13 West; thence run east, along the south boundary of the SW $\frac{1}{4}$ of SW $\frac{1}{4}$ and SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 31, Township 10 South, Range 13 West, a distance of 2640 feet to the southeast corner of SE $\frac{1}{4}$ of SW $\frac{1}{4}$; thence run north, along the east boundary of SE $\frac{1}{4}$ of SW $\frac{1}{4}$, a distance of 1490 feet to the centerline of U. S. Hwy. 278; thence run south 80 15' east, along the centerline of U. S. Highway 278, a distance of 10, 075 feet to a point in said highway, said point being approximately 660 feet east of the southwest corner of SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 33, Township 10 South, Range 13 West; thence run south along the east boundary of the W $\frac{1}{2}$ of NE $\frac{1}{4}$ to a point on the south boundary of NE $\frac{1}{4}$ of NW $\frac{1}{4}$; thence run west, along the south boundary of NE $\frac{1}{4}$ of NW $\frac{1}{4}$, the NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 4, Township 11 South, Range 13 West, a distance of approximately 1980 feet to the southwest corner of NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 4; thence run west, along the south boundary of NE $\frac{1}{4}$ and NW $\frac{1}{4}$ of Section 5, Township 11 South, Range 13 West, to the southwest corner of NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 5; thence run west, along the south boundary of NE $\frac{1}{4}$ and NW $\frac{1}{4}$ of Section 6, Township 11 South, Range 13 West, to the southwest corner of NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 6; thence run north, along the west boundary of NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 6, Township 11 South, Range 13 West, to the northwest corner of Section 6, and the point of beginning of the land herein described.
Motion was seconded by Larry Davis to accept petition and was passed unanimously.

There being no other business to come before the Council, the meeting was adjourned.
