BE IT ORDAINED by the City Council of the City of Hamilton, Alabama, that the governing body of said City does hereby assent to the annexation of the following described property to the City of Hamilton, Alabama:

Beginning where the center of Buttahatchee River intersects the south boundary of NE1 of SE1, Section 16, Township 11 South, Range 14 West; thence run west, along the south boundary of NE4 of SE4, the NW4 of SE4, NE4 of SW4, and the NW4 of SW4, to a point on the south boundary of the NW4 of SW4, said point lying 330 feet west from the southeast corner of NW4 of SW4, thence run north and parallel with the east boundary of NW% of SW%, a distance of 1320 feet to a point on the north boundary of NW% of SW%; thence run east, along the north boundary of NW4 of SW4, the distance of 330 feet to the northeast corner of NW% of SW%, thence run north, along the west boundary of SE4 of NW4, a distance of 660 feet to a point on said west boundary; thence run east, and parallel with south boundary of the SE% of NW%, a distance of 1320 feet to a point on east boundary of SE% of NW%; thence run south, along the east boundary of SE4 of NW4, a distance of approximately 75 feet to Woods Road Branch; thence meander and traverse Woods Road Branch in an easterly direction, a distance of approximately 1350 feet to where Woods Road Branch intersects the east boundary of SW4 of NE4, thence run north, along east boundary of SW4 of NE4, a distance of approximately 780 feet to the northeast corner of SW1/2 of NE $\frac{1}{4}$ ; thence run east, along the north boundary of SE $\frac{1}{4}$ of NE% a distance of 1320 feet to the northeast corner of  $SE_4$  of  $NE_4$ , thence run south, along the east boundary of SE¼ of NE¼ and the NE¼ of SE¼, a distance of approximately 1650 feet to where east boundary of the NE $\frac{1}{4}$  of SE $\frac{1}{4}$  intersects the center of Buttahatchee River; thence run downstream in west, southwesterly direction, traversing Buttahatchee River, a distance of approximately 1750 feet to where Buttahatchee River intersects the south boundary of the NE4 of SE4, and the point of beginning of the land herein described; said land lying and being in the S½ of SE½ of NW½, the E½ of E½ of NW% of SW%, the NE% of SW%, the S½ of SW% of NE%, the SE% of NE%, the NE% of SE%, and the NW% of SE%, all being in Section 16, Township 11 South, Range 14 West, Marion County, Alabama.
