

ORDINANCE NO. 440

BE IT ORDAINED by the City Council of the City of Hamilton, Alabama, that the governing body of said City does hereby assent to the annexation of the following described property to the City of Hamilton, Alabama:

Begin at intersection of Marion County Hwy. 35 and Buttahatchee River run in a Southwesterly direction along river approximately 1400 ft. to intersection of ditch; said ditch being the SE corner of property belonging to Douglas N. Lasher recorded in Deed Book 222, page 96; thence in a westerly direction along said ditch to its intersection with Marion County Hwy. 35; thence Southwesterly along said hwy. to intersection with the south line of Section 21; thence westerly along the south line of Section 21 and the south line of Section 20 to its intersection with Clark Creek; thence northwesterly along said creek to its intersection with the North line of SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 20; thence East along the north line of said SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ to east line of Section 20; thence northerly along said East line to SE corner of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$; thence northerly along the west line of the SW $\frac{1}{2}$ of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$; thence northerly along the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$; thence Easterly along the north line of the S $\frac{1}{2}$ of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ to the NE corner of said S $\frac{1}{2}$ of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 20; thence northerly to the NW corner of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$; thence easterly to the NE corner of said NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 20; thence continue East along North line of the SW $\frac{1}{2}$ of Section 21 to the SW corner of the SE $\frac{1}{4}$ of the SW $\frac{1}{2}$ of the NW $\frac{1}{4}$ of Section 21; thence in a northerly direction along the west line of the E $\frac{1}{2}$ of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ to its intersection with a gravel road; thence easterly along the south side of said gravel road to its intersection with the east line of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$; thence Southerly along the east line of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ and the east line of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ to the NW corner of property belonging to D. L. Greene as recorded in Deed Book 238, Page 245; thence northeasterly 435 ft. to the NW corner of D. L. Greene property; thence southeasterly 360 ft. to the NE corner of D. L. Greene property and Marion County Hwy. 35; thence northeasterly along said highway to its intersection with the Buttahatchee River and the point of beginning of the Property herein described. All lying and being in Section 20 and 21, Township 11 South, Range 14 West, in Marion County, Alabama,

and that a certified copy of this ordinance and attached thereto a plat or map of said property be delivered by E. T. Sims, Jr., Mayor to Honorable Annette Bozeman, Judge of Probate of Marion County, Alabama.
