

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HAMILTON,
ALABAMA, AS FOLLOWS:

Section 1. That, for the term beginning the first Monday in
October, 1980, the Mayor of the City of Hamilton, Alabama,
shall receive for performance of his duties as Mayor an
annual salary of \$16, 500.00, payable in equal monthly
installments of \$1325.00 out of the City Treasury.

In addition to his salary, the Mayor shall be
paid beginning the first Monday in October, 1980, as
reimbursement for his actual expenses incurred in the
performance of his duties as Mayor, subject, however, to
the approval of the City Council upon approval of such
expenses, they shall be paid out of the City Treasury.

Section 2. That, for the term beginning the first Monday in
October, 1980, each member of the City Council of the City
of Hamilton, Alabama, shall receive an annual salary of
\$600.00, payable in equal monthly installments of \$50.00
out of the City Treasury.

ORDINANCE NO. 410
Be it ordained by the City Council of the City of Hamilton, Alabama, as follows:
Section 1. That, for the term beginning the first Monday in October, 1980, the Mayor of the City of Hamilton, Alabama, shall receive for performance of his duties as Mayor an annual salary of \$16,500.00, payable in equal monthly installments of \$1325.00 out of the City Treasury.
In addition to his salary, the Mayor shall be paid beginning the first Monday in October, 1980, as reimbursement for his actual expenses incurred in the performance of his duties as Mayor, subject, however, to the approval of the City Council upon approval of such expenses, they shall be paid out of the City Treasury.
Section 2. That, for the term beginning the first Monday in October, 1980, each member of the City Council of the City of Hamilton, Alabama, shall receive an annual salary of \$600.00, payable in equal monthly installments of \$50.00 out of the City Treasury.
